Expressions of Interest

The Government of Republic of Srpska has received a grant from the International Bank for Reconstruction and Development (IBRD) in various currencies towards the cost of Second Solid Waste Management Project. It is intended that part of the proceeds of this grant will be applied to eligible payments under the contract for consultancy services for **“Supervision services for works on landfill rehabilitation, construction of gas collection system and construction of the sanitary cell at the landfill Ramici, Banja Luka”**.

Implementation period should be 14 months.

The Public Utility “DEP-OT” now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services.

Expressions of interest should include:

Interested consultants must provide information indicating that they are qualified to perform the services by fulfilling following requirements:

- Name, address and contact information of consulting Firm;
- Copies of original documents defining the legal status, place of Registration, etc;
- Reference list of the similar assignments (minimum of one project) in the last 5 years. Reference list should contain information about the client, project description, value of the contract and period of execution with the client's recommendation on Client's memorandum.

- Team leader

- An engineer of at least eight(8) years of professional experience relevant to the assignment, of which five years as project manager or team leader.

- Key staff

1. Civil Engineer with license for design and supervision for civil engineering facilities,
2. Civil Engineer with license for design and supervision for hydro technical facilities,
3. Electro Engineer with license for design and supervision for electro-technical installations and facilities,
4. Mechanical Engineer with license for design and supervision for mechanical-technical installations and facilities
5. Landfill gas expert with minimum three years of experience in operation of system for landfill gas collection and treatment

Required experience for a key staff is at least five(5) years of professional experience in similar condition.

The selected consultant has to provide additional documents before contract signing:

- license for design and supervision for civil engineering facilities issued by the Ministry of Physical Planning, Civil Engineering and Ecology of Republic of Srpska
- license for design and supervision for electro-technical installations and facilities issued by the Ministry of Physical Planning, Civil Engineering and Ecology of Republic of Srpska
- license for design and supervision for hydro technical facilities issued by the Ministry of Physical Planning, Civil Engineering and Ecology of Republic of Srpska
- license for design and supervision for mechanical-technical installations and facilities issued by the Ministry of Physical Planning, Civil Engineering and Ecology of Republic of Srpska
- key staff personal licenses issued by the Ministry of Physical Planning, Civil Engineering and Ecology of Republic of Srpska, except for landfill gas expert
