The Government of Republic of Srpska has received a loan from the International Bank for Reconstruction and Development (IBRD) in various currencies towards the cost of Second Solid Waste Management Project. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for **“Construction of the first sanitary cell at the landfill Ramici, Banja Luka.”**

2. The JP’’DEP-OT’’ Banja Luka now invites sealed bids from eligible bidders for the construction and completion of Construction of the first sanitary cell at the landfill Ramici, Banja Luka (‘‘the Works’’). The construction period is 7 months.

Bidding will be conducted through the international competitive bidding (ICB) procedures as specified in the World Bank’s Guidelines: Procurement under IBRD loans and IDA credits (current edition), and is open to all eligible bidders as defined in the guidelines.
